Dear Friends,

Despite the continued ups and downs of COVID, this past year was an exciting one for Jewish Family Service of MetroWest (JFS). With a decrease in government funding and the demand for our services at an all-time high, we are thankful to our donors for their support in helping to bridge the gap. We have helped more than 6000 individuals through direct services, engaged with 700+ community members at our educational workshops, and partnered with 20+ synagogues and schools to ensure that we met the community where the needs were greatest. We strive to provide the highest quality services for all.



We renamed our volunteer services after Maxine Myers z”l, whose dedication to all JFS programs exemplified the way our donors and board members work with our staff to support and enhance our services. The Maxine Myers JFS Volunteer department utilized 180 volunteers to help so many in need through existing programs like Reading Buddies, SHIP and MIPPA (Medicare enrollment services), and Money Management, and also launched new programs like Tessie’s Touch, a unique approach to supporting isolated older adults.

A generous gift from Carrie and Jed Nussbaum allowed us to create a new Case Management program that helps and supports older adults learn about and access resources to enable them to live independently for as long as possible. While COVID may be abating, the mental health crisis it magnified is ongoing, with a 28% increase in calls for mental health services throughout all of our departments. We have worked tirelessly to serve as many clients as we can. We have created new support groups, to expedite assisting those in need and minimize waitlists.

We launched a corporate partnership program through our development office, and are grateful for our originating members: ShopRite of West Caldwell and Parsippany, BNE Realty Group, Preferred Client LLC, Shufro Rose, Sax Accounting, McCarter & English, Saritte Harel Realty Group, Lereah Financial Group, New Frontier, Toshiba Business Solutions, Goldman Sachs, and Amanda Damasek, Realtor. We are thrilled with the success of this program, and welcome the opportunity to highlight businesses in our community.

These examples and all of the statistics and information published here tell one piece of the story of our accomplishments in 2021-2022, the recognition we receive from you and the impact of your support cannot be adequately expressed within the boundaries of this report. **JFS & You** is not just a tagline, it’s the foundation on which we serve the community each and every day. 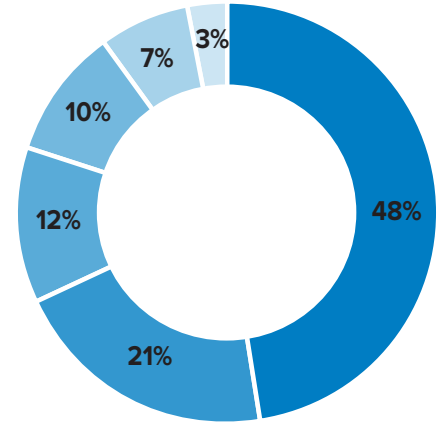

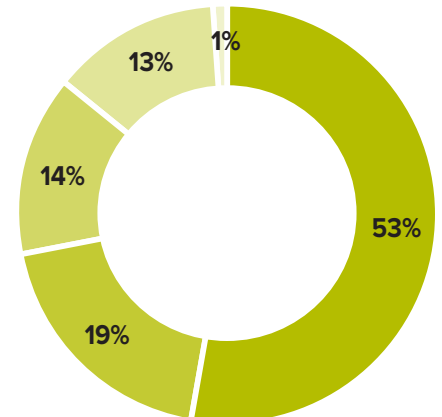
