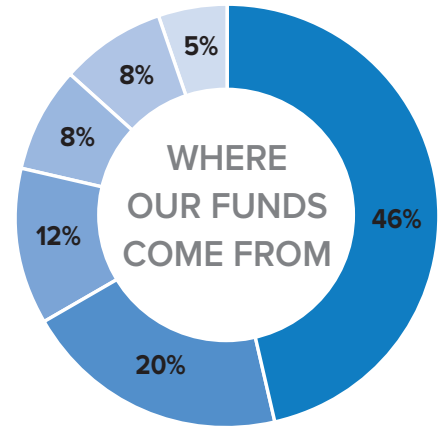

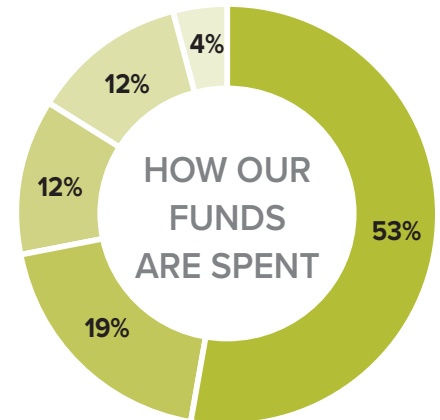

Dear Friends,

This year brought a lot of exciting changes to JFS. After months of planning, we moved into our new spaces at 30A Vreeland Road in Florham Park and 300 Executive Drive in West Orange. These locations enable us to grow some of the most important services we offer to the MetroWest community. Therapy and counseling, support for caregivers, case management for older adults, domestic violence counseling and legal services, and volunteer programs for all ages now have room to expand. Our new welcoming settings reflect the quality work we do.

The timing could not have been more important. Referrals to our counseling services continue to grow. Calls from victims of domestic violence have doubled. Those of us in the sandwich generation feel the continuing strain of caring for parents while raising children. Our Care Consultation program, which supports caregivers, has been growing steadily as more families look to us for help navigating the challenges of aging.

Our volunteer services are more relevant than ever as our community grows older. The Maxine Myers Volunteer Department gives community members, including older adults, meaningful opportunities to stay engaged while supporting others through programs like Reading Buddies, Friendly Visiting, Tessie's Touch, Medicare enrollment help, and holiday meals for Holocaust survivors and isolated older adults.

All of this work has one goal, supporting the people in our community who need us. We are fortunate to have volunteers, donors, board members, and partners who stand with us and help move our mission forward. This year's gala highlighted just a few of them. Thelma and Richard Florin received the Lifetime Philanthropy Award for their generosity. The Maxine Myers Volunteer Award went to Howard Medow, a dedicated Reading Buddy since 2019. New Frontier was honored as our Community Partner for more than a decade of creative and committed support, including building a website that serves as the community's front door to JFS and makes it easier for people to find the help they need. The Community Impact Award went to Terri Friedman, whose longtime volunteer work and strong advocacy across the Jewish community continue to raise awareness of our mission and connect more people to our services.

At the same time, we want to be honest about the challenges ahead. The demand for our services is rising faster than our funding. We are facing real deficits this year. But we are not backing away from any of this. We are committed to securing the resources we need, and we have already seen our community step forward. When the need grows, our community rises to meet it. We have done it before, and we will do it again.

We are proud to share our FY25 Annual Report, which highlights the scope of our work and illustrates the impact your support makes possible. Thank you for standing with us, for believing in our mission, and for helping us meet the growing needs of our community.

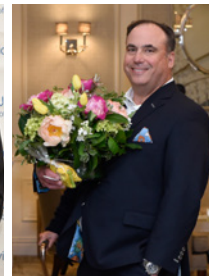
